To register to vote, you must be:

- a U.S. citizen,
- 18 years old by the time of the general election, and
- a resident of your precinct for at least 30 days prior to the election.

Registration can be done at the Montgomery County Voter Registration Office (in person or by mail) or the Bureau of Motor Vehicles (in person). You must register to vote at least 29 days prior to the election in which you will be voting. If you apply by mail, your form must be postmarked no later than 29 days prior to the election. If you change your address or your name, you must change your registration.
